Other responsibilities of this role will include curriculum design and support, internal and external verification processes, and general study programme management (this will include elements of specific awarding body and DfE compliance). You will respond to student welfare issues effectively and maintain high quality assurance and professional standards throughout. Main duties:

- Maintain high quality standards for Performing Arts for LEAD Education.
- Oversee and manage the LEAD Education study programme at learning sites (North)
- Attend weekly meetings with line manager and report on the status of learning centres in terms of the study programme, assessment, grades, student behavior, attendance, and general issues.
- Work with the line manager to develop standards across the programme.
- Collaborate with external providers (awarding bodies) to ensure current guidelines are met.
- Communicate with learning sites to ensure quality standards are maintained by:
 - Internally verifying all documents
 - Creating LEAD resources and support materials (e.g., milestone guides) for all centres to utilise to create a standard across LEAD Education
 - Verifying all assessment decisions to check assessment standard is quality assured across multiple centres.
 - Ensuring the Onedrive system is regularly monitored and work is uploaded efficiently.
 - Maintaining oversight of grade trackers to ensure these are completed continuously.
 - Completing target grades and monitoring grades for learners at centres.
 - Ensuring learning site staff attend mandatory CPD sessions (including awarding body standardisation training).
- Create Performing Arts assessment plans that are personalised for individual learning centres.
- To be Internal Verifier for Performing Arts for LEAD Education, overseeing a 'division' of centres.
- To prepare and co-ordinate external standardisation (SV) with line manager.
- Maintain up to date knowledge and understanding of awarding body Level 2 and 3 qualifications in Performing Arts.
- To establish and maintain strong, professional relationships with all providers, assessors, teachers and learners.
- To inform line manager of areas of training for centres and staff.
- To provide specific awarding body teaching and learning support to centres, staff and learners. This be held through weekly/bi weekly check ins. Check ins will be mainly remotely.

- To organise both meetings and visits with all relevant staff. Remote meetings to be held weekly (within working hours) and termly face-to-face visits with centres.
- Monitor attendance at centres to ensure all learners remain over 90% attendance on study programme. Continually monitor and discuss with centres, create improvement plans where necessary. This must be followed up with action and reported to the line manager.
- To work with centres to implement behavior plans where necessary if students fail to meet deadlines and/or have a poor attitude to learning.
- If required, deliver high level, engaging student support sessions to ensure students are aware of grading criteria and how to progress.
- Support the diverse ability levels of staff, helping to bridge the gap between high level performing arts teaching and pedagogy; ensuring staff attend CPD.
- Differentiate curriculum plans to meet individual learning site needs.
- Demonstrate impeccable communication skills with all other staff members.
- Respond effectively, appropriately and in a timely manner to our client's needs, prioritising tasks.
- Maintain good, positive working relationships with all LEAD clients demonstrating excellent customer service skills.
